Objectives

This workshop aims to examine the spatial representations of nomadic societies and landscapes in Northeast Asia from multiple perspectives. The main focus is on nomadic concepts of land and nature, spatial perceptions of nomadic societies, and the impact of sedentary viewpoints on nomadic societies. Additionally, an important theme is how the political legacy of colonialism relates to nomadic rights and spatial justice.

In the first half of the workshop, we will discuss the nature of nomadic space. The second part of the workshop will analyze spatial representations of nomadic societies through a critique of cartographic practices. This analysis will consider how maps have historically been used to represent mobile land use and create new social categories, particularly during periods of political transition. This workshop aims to understand how outsiders have spatially represented nomadic societies and how nomadic societies create and represent their own spaces.
